ABOUT THE BISCAYNE BAY COMMISSION

On June 3, 2021, Florida Governor Ron DeSantis took a major step forward in protecting vital natural resources within Biscayne Bay through the creation of the Biscayne Bay Commission. While Biscayne Bay is protected in its entirety by either a national park or state aquatic preserve, it faces global, regional and local stressors. The Governor supports direct action to strengthen coordination efforts to protect Biscayne Bay and protect and preserve the integrity of the Bay. Commission meetings provide a forum for exchange and serve as a clearinghouse for public information on all plans, programs and projects being conducted.

As required by statute, the Biscayne Bay Commission developed a strategic plan and compiled an associated financial plan in partnership with local agencies.

This Semiannual Report is made available to describe the accomplishments of the commission and each member agency and the status of each pending task. This includes:

- Attachment A – Project Tracker: Updated as new information is available by the member agencies, this tracker identifies projects and tasks designed to improve Biscayne Bay. Information on the spreadsheet primarily includes project name, description, project type and project status.
- Attachment B – Financial Plan: Copy of the consolidated financial plan through 2024, inclusive of any necessary updates.
- Attachment C – Biscayne Bay Commission Strategic Plan: A strategic plan was approved by the commission on January 19, 2024, and includes strategies for three strategic goals including enhancing water quality monitoring, improving communication and outreach and addressing sources of nutrients and ecosystem restoration needs.

Jan. 24, 2025

The Biscayne Bay Commission met on Jan. 24, 2025, virtually via GoTo Webinar. The meeting welcomed 110 total participants to hear presentations, discussion, and public comment.

This meeting included an update from the Biscayne Bay Watershed Advisory Board, presented by Danielle Cohen-Higgins, District 8 Miami-Dade County Commissioner, and team members from Miami-Dade County; a Reasonable Assurance Plan update, presented by Pamela Sweeney of Miami-Dade County; and a review of the Strategic Plan and Project Tracker, presented by Hampton Hotard, the Biscayne Bay Commission Coordinator on behalf of the Biscayne Bay Aquatic Preserve. These presentations were followed by public comment, commission discussion, and closing remarks.

Apr. 2, 2025

The Biscayne Bay Commission met on Apr. 2, 2025, at Florida International University's Biscayne Bay Campus and via GoTo Webinar. The meeting welcomed approximately 102 total participants (67 online attendees, 35 in-person attendees) to hear presentations, discussion and public comment.

This meeting included a Water and Sewer Department presentation, presented by Amanda Kinnick, the Interim Director of Miami-Dade County's Water and Sewer Department; an Environmentally Endangered Lands (EEL) Program update, presented by Janet Gil, EEL Program Director; a Stormwater and Canal Management update, presented by Matahel Ansar and Richard Virgil, on behalf of the South Florida Water Management District; and an update on the Biscayne Bay Water Quality Improvement Grant Program, presented by Mollie Cordo, on behalf of the Florida Department of Environmental Protection. These presentations were followed by public comment, commission discussion and closing remarks.

Jul. 23, 2025

The Biscayne Bay Commission met on July 23, 2025, at Florida International University's Biscayne Bay Campus and via GoTo Webinar. The meeting welcomed 101 total participants (79 online attendees, 22 in-person attendees) to hear presentations, discussion and public comment.

This meeting included a Florida Fish and Wildlife Conservation Commission presentation given by David Holmberg, a south regional biologist; a presentation on the resiliency of urban corals given by Ashely Rossin with the National Oceanic and Atmospheric Administration's Atlantic Oceanographic and Meteorological Laboratory and the University of Miami Rosenstiel School of Marine, Atmospheric, and Earth Science's Cooperative Institute for Marine and Atmospheric Studies; a presentation on the Biscayne Bay Aquatic Preserves (BBAP) water quality monitoring program from the BBAP water quality technician, Tristan Clute; and an overview of the BBAP benthic monitoring program from the BBAP spatial ecology coordinator, Veronica Lopez. These presentations were followed by public comment, commission discussion and closing remarks.

Nov. 12, 2025

The Biscayne Bay Commission met on Nov. 12, 2025, online via GoTo Webinar. The meeting welcomed 77 attendees to hear presentations, discussion and public comment.

This meeting included an update on the Biscayne Bay Aquatic Preserve 2025 Management Plan review and approval process presented by BBAP Manager Griffin Alexander; a Reasonable Assurance Plan update, presented by Pamela Sweeney of Miami-Dade County; a South Florida Water Management District presentation provided by Richard Virgil on canal management and recent marine debris removals; and a walkthrough of the Protecting Florida Together website and Water Quality Status Dashboard by Sara Davis and Julia Danyuk of the Florida Department of Environmental Protection. These presentations were followed by public comment, commission discussion and closing remarks.

STATUS OF PENDING TASKS

The commission has and will continue to discuss these tasks identified in statute and how to address each at upcoming meetings. Tasks include:

- (a) Consolidate existing plans, programs and proposals, including the recommendations outlined in the [June 2020 Biscayne Bay Task Force report](#), into a coordinated strategic plan for improvement of Biscayne Bay and the surrounding areas, addressing environmental, economic, social, recreational and aesthetic issues.
 - The commission used the six categories listed in the June 2020 Biscayne Bay Task Force report to inspire discussion around developing the strategic plan for Biscayne Bay.
 - A final version of the Biscayne Bay Commission Strategic Plan was approved by the commission at the January 2024 meeting. The Biscayne Bay Strategic Plan is included here as Attachment C and is published [online](#).
- (b) Prepare a consolidated financial plan using the projected financial resources available from the different jurisdictional agencies. The commission will monitor the progress of each element of the plan and revise the plan regularly.
 - A financial resources report is provided as Attachment B.
- (c) Provide technical assistance and support as needed to help implement each element of the strategic and financial plans.
 - A presentation on the Strategic Plan implementation is to be presented annually to the Commission and presentation and discussion is available by viewing meeting minutes and materials.
- (d) Work in consultation with the U.S. Department of the Interior.
 - No updates to report. See previous [January 2025 Semiannual Report](#).
- (e) Provide a forum for exchange of information.
 - Commission meetings are public forums conducted in accordance with the Sunshine Law. Members of the public may provide written and oral comments during the meeting or email comments after the meeting to BiscayneBayCommission@FloridaDEP.gov.
 - Coordination with the MDC Watershed Advisory Board:
 - MDC's Chief Bay Officer is invited to provide an overview/update from the board at the MDC Watershed Advisory Board. Updates are available on the [Biscayne Bay webpage](#). DEP also furnishes meeting summaries. In addition, the commission discussed these two groups magnifying awareness of the issue at hand and

amplifying the potential for environmental change by using the same talking points for projects where all levels of government aggregate actions focus on one basin.

(f) Act as a clearinghouse for public information.
